## Financial Support for Families

Colac Secondary College understands that some families may experience financial difficulty and offers a range of support options, including:

#### Centrelink

Parents in receipt of Centrelink payments can direct a portion of this to the school each fortnight. This can be used as a payment plan for year level contributions and other school related costs (excluding iPads). iPads are to be purchased via an external provider.

#### Appointments

Parents who experience difficulties providing or paying the school to provide essential education items are encouraged to make an appointment with the Parent Payment Officer to discuss alternative payment methods. Please phone 5231 9800 to make an appointment.

## • Sibling Discount AND Early Bird Discount on year level contributions

Families with multiple students are eligible to receive sibling discounts. See below table. Early bird discounts also apply to every student if payment is made by December 10, 2021.

#### Payment Plans

Provides another way, in addition to Centrepay, for parents to 'pay off' school related charges in a time frame that suits their needs.

#### Camps, Sports & Excursions Fund (CSEF)

This payment is paid directly to the College to Parents / Guardians with an eligible Centrelink benefit card and can be utilised for any camp, sport or excursion only. Funds are not to be passed onto Parents / Guardians but will stay against the family account, and rollover from year to year if not used.

## **FREE INSTRUCTION**

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.

## **PARENT PAYMENT REQUESTS**

Schools can request contributions from parents under three categories:



#### **Curriculum Contributions**

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

# Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

# Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

• Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



## FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



## **SCHOOL PROCESSES**
